Community Service-providing vision screening programs for the early detection of signs of eye problems among preschool children, school age children and adults, particularly amblyopia (lazy eye) in children and glaucoma in adults. Vision screenings were provided for 215,377 children and 274 adults in Wisconsin.

Public Education-informing the general public about the basic facts of eye care, health and safety, and motivating them to appropriate action; accomplished through exhibiting at health fairs, presentations to civic groups, through mass media such as newspaper and website, through the distribution of Prevent Blindness Wisconsin and Prevent Blindness America educational publications, and through the dissemination of information to public health depts, school nurses, and responses to phone, e-mail & written inquiries from the public. 34,408 people recieved information and referral services. Prevent Blindness Wisconsin's website has had 9,981 visitor sessions, 7,390 unique visitors and 28,571 page views.
