Certified vision screenings detect children and adults with potential vision problems and refer them to further vision care; early detection and treatment of vision problems improves treatment outcomes, prevents permanent vision loss, and ensures children have the healthy vision for school success. Public Education-Prevent Blindness Wisconsin provides public education to teach the general public about vision health topics such as: the importance of healthy vision, common vision problems and their signs, vision safety, the prevention of eye disease, and how to access vision care. Vision health education is provided through presentations to parents, educators, community groups, and others; mass media advertising including local publications and transit systems; distribution of Prevent Blindness Wisconsin educational materials; the Prevent Blindness Wisconsin website and more.
